TERMS AND CONDITIONS

Conditions of Carriage: The following conditions apply unless otherwise stated above by reference.

Cube Density (CBE) And Long Freight Rule	All rates are subject to 10 lbs per cubic foot (pcf) unless otherwise specified. $10 \text{ lbs/pcf} = \text{length (in)} \times \text{Width (in)} \times \text{height (in)} \text{ divide by } 1728 \times 10$. If this amount is more than the actual weight of the shipment then the cubed weight would apply to calculate the freight charges. When it is not possible to load on top of a shipment, the cube dimensions for that shipment will be based on a minimum height of 8 feet. Any piece or bundles that is less than 12" in diameter and weighs less than 250lbs will be rated at actual weight. Any piece or bundle in excess of 12" in diameter and heavier than 250lbs that, because of its dimension does not allow 2 skids to be placed side by side, will be cubed at 4' wide by 4' high by the actual length.
Linear Foot Rule	1000 lbs per linear foot for shipments occupying 10 feet or more of trailer. When the freight occupies 10 feet of trailer space or more, or is packaged in such a way that other freight cannot be stored on top of or on either side of it, the chargeable weight will be calculated at 1000 lbs per linear foot of space use.
Liability	The maximum liability for goods lost, damaged or delayed will be the lesser of the actual value of the goods at the time and place of shipping and \$2.00 per pound (\$4.41 per kilogram) based on the weight of the goods lost, damaged or delayed. Minimax will not be responsible for any damages or claims for shipments of new empty cans or bottles that are piled more than 6 ft high on skids.
Pickup/Delivery	Minimax Express shall not be liable for fines or penalties that may be imposed by the consignee or shipper resulting from a missed pickup, late delivery, missed appointment or lost and damaged freight.
Identification and Packaging of Freight	Minimax Express shall not be liable for loss or damage caused by fault or negligence of the shipper and/or consignee, such as the inadequate identification of goods, improperly packaged goods, packaging failure or damage caused during the palletizing of products. Freight should not exceed the dimensions of the pallet.
Concealed Damage	The consignee must advise Minimax Express of concealed damages no later than 24 hours after the goods have been received. Concealed damages are damages found inside the packaging that are not visible on the outside of the packing at time of delivery.
Counting of Goods	Minimax Express is not liable for the counting and condition of goods delivered or picked up where our drivers have no access to the loading or unloading areas. It is the consignee's responsibility to count the goods at the time of delivery.



Terms and Conditions Continued

Heated Service	For the purpose of this agreement heated service means protect from freezing.
Declared Value	Any declared value must be previously agreed to in writing or specific contract before Minimax Express handles the goods.
Claims	Claims for loss and damage need to be given in writing to Minimax Express within 60 days of the delivery of the goods, or in the case of failure to make delivery 9 months from the date of the shipment. Claims of an amount of less than \$50.00 will be declined. The customer shall not deduct from invoices to be paid any claimed amounts to Minimax Express without the written consent of Minimax Express.
Dangerous Goods	Every person whether as principal or agent shipping dangerous goods without previous full disclosure to the carrier as prescribed by law shall indemnify the carrier against all loss, damage or delay caused thereby and such goods may be warehoused at the consignor's risk and expense.
Payment Terms	Our terms are net 30 days from the date on the invoice. The customer agrees to pay interest at the rate of 2% per month (24% per year) on past due invoices.
Activity	This rate confirmation will become void if committed shipping volume is not met.
Commitment	This rate confirmation is based on the information provided by the customer during the sales process. If the information received is incorrect or no shipments have been tendered within 60 days of the effective date Minimax Express reserves the right to cancel the rate confirmation.

Conditions of Carriage

Standard Service	The above rates include a normal pick up and delivery during regular business hours. Our regular business hours are from 8:00am to 5:00pm Monday through Friday. Pickups and deliveries outside of the normal hours will incur additional costs. Our pick ups and deliveries are mainly performed using 53' trailers and require dock level receiving and shipping doors which are easily accessible. Other types of equipment are available but will incur additional costs. Pickup requests received before 12pm (noon) will be prioritized for pickup the same day. Service to outlying points can be delayed when volume is insufficient.
Subject to Change	Accessorial charges, terms and conditions are subject to change with 30 days notice.
